	<ul style="list-style-type: none"><li>- Addressing the challenges due to COVID-19</li></ul> <p>Unlike in previous years, TIER 1 will equal ARD. So, we are guaranteed the same funding for our renewals as last year. In past, 93% of ARD was placed TIER 1, so we had to score high enough to receive funding for the other 7%.</p> <p>Bonus money for DV project providing RRH or PSH. CoC Bonus money for new projects depending on how we score on our application.</p> <p>HUD has given more specific direction on scoring criteria.</p> <p>Timeline must be adhered to. Very specific, timely tasks starting with posting to websites</p> <p>Rank and review process will begin once all project applications are in.</p> <p>Voluntary Re-allocation statements must be submitted, if any apply.</p> <p>NOFA due on 11/16/21. We will submit prior to this date.</p>
